

BOARD OF SELECTMEN MEETING MINUTES MARCH 24, 2020

A regular Board of Selectmen meeting was held on Tuesday, March 24, 2020, at the Swansea School Administration Building, One Gardners Neck Road, Swansea, Massachusetts.

The meeting was called to order at 6:30 p.m.

Mr. Kitchin led the meeting with the Pledge of Allegiance.

Mr. Kitchin announced this evening's meeting is being broadcast live on Swansea Cable Access TV and will be re-broadcast several times throughout the month.

Mr. Kitchin stated in order to comply with Governor Baker's executive order, no more than ten people are present.

APPOINTMENT – CONFIDENTIAL ADMINISTRATIVE ASSISTANT TO THE CHIEF OF POLICE – SWANSEA POLICE DEPARTMENT

Stephanie Borges Albernaz, Swansea, MA

As a point of reference, Mr. Heim said he would not be participating.

Police Chief George Arruda respectfully requested the appointment of Stephanie Borges Albernaz, Swansea, MA, age 37, 51 High Hill Road, to the position of Confidential Administrative Assistant to the Chief of Police.

Chief Arruda said Stephanie has gone through the application process, interview process with Lieutenant Haslam, Lieutenant Martin, and himself. A background check is being conducted, and a medical exam is scheduled.

Chief Arruda said the position was advertised on INDEED. Thirty-four applications were received, eight were interviewed, and he felt that Stephanie was the best applicant.

Mr. Carreiro said it is great to see a local person and graduate of Case High School being appointed for the position. He went over her qualifications and educational background. He had no objection.

Mr. Kitchin said as always, Chief Arruda's applicants are of extreme caliber. He has no objection in making this appointment. He shares Mr. Carreiro's enthusiasm to have someone from Swansea filling this position.

COVID-19 (CORONAVIRUS) UPDATE – EMERGENCY MANAGEMENT

Eric Hajder, Fire Chief

Municipal Operations

James Purcell, Acting Town Administrator, Tracy Jo Anderson, Town Accountant – M.G.L. c44-S31: Emergency Expenditures related to COVID-19

Mr. Kitchin announced he received an unfortunate phone call Sunday, informing him that Swansea has its first case of coronavirus.

Fire Chief Hajder gave an update as it relates to the coronavirus. He said the task force meets regularly to discuss topics and they have a very good grasp on what efforts we will take at this time.

Fire Chief Hajder thanked Police Chief Arruda for his support during this process.

Chief Hajder said town departments are working on a limited basis. He noted town buildings are closed to the public and have limited access.

The public safety departments are properly prepared and are well equipped at this time. They are ready to respond to the needs of the residents.

Chief Hajder commended the work done by the task force. He said in all, we're in a good position to handle what is before us.

Chief Hajder urged the citizens of Swansea to visit the town website for updated information on the coronavirus, and urged residents to stay home when they can, practice social distancing, and to continue to wash their hands and check in on one another.

Members of the task force include Fire Chief Eric Hajder, Police Chief George Arruda, Police Lieutenant Marc Haslam, Deputy Fire Chief Michael Patterson, Town Nurse Emily Lachance, Director/Health Agent of the Board of Health Zachary Seabury, representatives from the Selectmen's Office, Acting Town Administrator Mr. James Purcell, Administrative Assistant Mr. Jordan Remy, and Emergency Management Coordinator, Mr. Carl Sawejko.

Chief Hajder stressed how instrumental Emily Lachance has been during this crisis.

Mr. Kitchin thanked the members of the task force for their efforts.

Mr. Purcell advised that the matters we can control are under control. He gave an update on extending deadlines for permits, etc., and identified the essential people in the Town Hall Offices, the Town Hall Annex Departments, Highway Department, and Council on Aging. He stated the work force by and large right now is very healthy.

Mr. Kitchin had a conversation with Tracy Jo Anderson, Town Accountant, relative to emergency expenditures related to COVID-19. Mrs. Anderson has created an account for these emergency expenditures and is keeping track of the expenditures that need to occur. In the event FEMA or the State is in position to reimburse the town, we will have an accurate accounting of those costs to submit for reimbursement.

Mr. Heim said it is important to recognize the hard work of our employees.

Mr. Heim said he received a phone call from Mr. Seabury, Board of Health, stating he was not notified of an incident. He stressed the importance to be sure the Board of Health is notified.

He has also received calls from residents stating that people doing pick up or take out at restaurants are congregating inside the restaurant. They should be waiting in their car.

Mr. Heim said he has also received phone calls asking for information on the Memorial Day Parade and Little League opening day. He advised people to utilize their website pages.

Mr. Carreiro proposed an amnesty program for the pay-as-you throw trash program. He said folks shouldn't be going out just to buy trash bags.

Mr. Kitchin asked Mr. Purcell to contact Mr. Anderson, Engineer/Director of Highway Services, regarding a potential amnesty of trash bags to see if it is possible for a period of time.

Mr. Carreiro explained that certified free cash is for instances such as this, and can be used to pay any type of expense.

Mr. Kitchin concurred with Mr. Carreiro's proposal.

Mr. Kitchin reported on questions Mr. Heim had raised about potential flexibility for property taxes and motor vehicle taxes. He said Mrs. Beth Leonardo, Tax Collector, determined due to the current state of affairs, there is no plan to mail out late or demand notices for motor vehicle excise tax bills until the end of April without penalty. Excise tax bills are due March 27th.

Mr. Kitchin has sought opinions of the Department of Revenue relative to tax forgiveness for 4th quarter property tax bill. He said at this time the Governor and House of Legislature have a bill before them that would provide the type of relief Mr. Heim specifically asked about and would allow the Selectmen to make the necessary decision to allow relief. As things stand right now, the property tax bill is due May 1st.

Mr. Kitchin said he would encourage that we reach out to our legislative delegation and encourage them to provide some relief to the citizens of Swansea.

Fire Chief Hajder went over the line items. As he recommended, the budget is level funded.

Mr. Kitchin commented on a topic Mr. Purcell raised at the last meeting.

Mr. Purcell highlighted and summarized the contract renewal of Good Day Energy that expires at the end of the year.

Mr. Purcell said conditions are favorable right now, and he would like to lock in for the next five years. He said he would be the town's representative, and Mr. Anderson (Highway Engineer) would be the alternate representative.

There were no objections.

MOTION made by Mr. Derek W. Heim and seconded by Mr. Christopher R. Carreiro, to appoint Mr. James Purcell as our Good Day Energy representative for the Good Day Energy Service Agreement.

SEWER TASK FORCE COMMITTEE

Mr. Kitchin referred to an article that was passed on May 15, 1978, relative to a joint effort with Somerset.

Mr. Purcell said we have had engineering studies commissioned for the Towns of Somerset and Swansea for flow calculations and the like.

Mr. Purcell said Somerset is in the position of a serious need for improving their sewage treatment flow capacity, and their collection system is in need of rehab. He said it's an ideal time for both towns to join forces if we find it makes economic sense.

Attorney Joseph Cove, representing Somerset recommended that Swansea form a Sewer Committee.

Mr. Purcell said in 1978 a Sewer Study Committee comprised of three Selectmen and three citizens at large was formed.

Mr. Kitchin asked his colleagues how they would like to go through the solicitation for the three citizens.

Mr. Heim recommended asking anyone interested to send a letter of interest to the Board of Selectmen Office.

Mr. Carreiro recommended representation from a member of the Economic Development Committee, a member of the Board of Selectmen, and a member of Advisory & Finance.

Mr. Kitchin recommended that we reach out to these boards and committees to see if there is a member that would be interested in serving on the sewer committee, and made an appeal to all Swansea citizens that are interested, to reach out to the Selectmen Office with a phone call or a letter expressing interest to be on the Sewer Task Force Committee.

Mr. Carreiro inquired about the status of the Redevelopment Authority. He said the members are eager to meet. He said the mall is advancing right now and in the process of demolishing the interior, and a lot of progress is being made.

Mr. Jordan Remy announced the RDA has been officially been certified by the Secretary of State and Community Development as a public political body. It can officially take votes and take action.

Mr. Remy had a conversation with the Chairman of the RDA and he indicated the group wishes to meet next month.

Mr. Carreiro commented that McMcAuliffe was providing guidance to the RDA and was attending their meetings.

Mr. Purcell will step in for McMcAuliffe in his absence to assist the RDA.

Mr. Carreiro said we are advancing on collective bargaining.

Mr. Purcell said a planned bargaining meeting has been postponed.

Mr. Heim announced that Meet the Candidates Night has been postponed for the time being.

Mr. Heim referenced to our public waterways. He said he would like an update on where we stand at the next meeting.

Mr. Kitchin said he would like some clarity as to the next steps in the appointment process of the Redevelopment Authority.

Mr. Kitchin stated he would like to see the liquor license policy completed.

Mr. Heim stated that money was allocated last year for the removal of a building at the SIBL baseball field at the end of Nike Site Road. He said the building is a complete public nuisance. The roof has caved in and the building is wide open.

Mr. Heim said he advocated for funds last year for this purpose and is asking for an update.

NEW BUSINESS

Noise Complaints: Gardners Neck Road, Brayton Point

Mr. Carreiro stated the activity at Brayton Point in Somerset has become a Swansea issue. He has heard from residents on Gardners Neck Road regarding the noise.

Mr. Carreiro said a citizen on Norwood Street has contacted him and would like to attend a Selectmen Meeting.

There was a discussion on the matter.

Mr. Kitchin said it is important we should listen to what this constituent has to say. He asked Mr. Carreiro for a communication in writing.

Mr. Kitchin said he doesn't want this constituent to feel we are not listening. It is just a matter of priorities we are dealing with right now.

He said the matter will be on our agenda as soon as we can get through some of the emergency management details we're working on right now.

Mr. Kitchin inquired about the property at Maple Street and the former site (Knights of Columbus) where 40B housing was going to go up.

Mr. Carreiro said there has been an acquisition that just took title.

Mr. Kitchin advised that we communicate with the old owner or the new owner. He said property needs to be secured, it is an attractive nuisance and danger that requires someone's attention. He said we are seriously considering securing it and placing a lien on the property.

Before adjourning, Mr. Kitchin asked the citizens of Swansea to do everything they can in these trying times to comply with the Governor's executive order, and to be safe.
